### KEY HIGHLIGHTS

# BUSINESS SERVICES THIRD QUARTER 2021 KEY HIGHLIGHTS

After rising over 13% through Q2 2021, the SOLIC Business Services Sector Index ("SBSS Index") was essentially flat during Q3 2021, increasing 0.7% in Q3 2021 compared to a 6.6% increase for the S&P 500. In particular, concern over the growing impact of the delta variant, along with rising inflation and supply chain challenges, caused stocks of services-related businesses to pull back in August and September. Stocks of Marketing Services (-11.5%) and Professional Staffing (-5%) experienced the greatest pullback in Q3, while IT Consulting (+8.4%), Specialty Consulting (+4.8%) and Information Services (+4.5%) experienced the strongest performance.

M&A during Q3 remained extremely strong across all sectors with several high profile strategic mergers and private equity continuing to be very aggressive in pursuing platform investments. Notable transactions from Q3 2021 include:

- Sykes Enterprises (NASDAQ: SYKE), an international provider of call center support for customer care, marketing and technical support, was acquired by Sitel Group for \$2.1B
- ManpowerGroup (NYS: MAN) acquired ettain group, one of the largest IT staffing providers in the US. for \$925M in cash
- CVC and TA Associates made an investment in Mediaocean, a provider of omnichannel advertising management that uses proprietary software to optimize advertising spending
- TransUnion (NYSE: TRU) acquired NeuStar, a provider of identity resolution and corroboration solutions with over 8.000 clients worldwide
- Marlin Equity Partners acquired Prize Logic, a provider of incentive-based digital marketing services comprising digital promotions, rebates and loyalty programs
- Randstad acquired Cella, the fifth-largest US staffing firm for marketing and creative professionals, for \$130M

We expect M&A activity to remain robust throughout 2021 as strategic acquirors look to position themselves for pandemic growth and institutional investors seek to capture opportunities as the economy continues to strengthen.






### **Enterprise Value to Revenue**




### **Enterprise Value to EBITDA**



# **Business Services Sectors: Total Enterprise Value / Revenue**




# **Business Services Sectors: Total Enterprise Value / EBITDA**








### **Net Change in U.S. Employment**
