BUSINESS SERVICES FOURTH QUARTER 2021

The SOLIC Business Services Sector Index ("SBSS Index") rose 8.7% in Q4 2021, consistent with the 9.4% increase for the S&P 500. While the Business Services sector overall was consistent with broader markets, there was significant divergence within subsectors. The IT Consulting index was up by over 24% and the HR Services index increased by 18.3%, led by payroll companies such as ADP and Paychex and the view that such companies would benefit from accelerating employment in 2022 as well as rising interest rates. On the other side, the Professional Staffing Index was up only 1.9% during the quarter, representing a pull back after record appreciation during the first half of 2021.

M&A remained extremely strong across all sectors during Q4 with several high profile strategic mergers and private equity continuing to be very aggressive in pursuing platform investments. Notable transactions from Q4 2021 include:

- Intuit (NASDAQ: INTU), maker of TurboTax and QuickBooks, acquired email marketing provider MailChimp for \$12 billion
- EmployBridge, the largest U.S. industrial staffing provider and a portfolio company of Apollo Global Management, acquired Hire Dynamics, an industrial staffing firm with over \$260 million in revenue
- Hudson Global Inc. (NASDAQ: HSON), a provider of recruitment process outsourcing, acquired Karani LLC, a Chicago-based recruiting firm with operations in India and the Philippines
- MidOcean Partners acquired GHR Healthcare, a provider of travel and per diem nursing, allied health, revenue cycle, and educational staffing
- Kelso Private Equity acquired ResourcePro, a provider of outsourced business process management and consulting / advisory services to insurance brokers and TPAs
- Unisys (NYS: UIS) acquired CompuGain

We expect M&A activity to continue at its heightened 2021 levels during the first half of 2022 as private equity firms seek to aggressively deploy capital and strategic acquirors position themselves for the post-pandemic economy.







Business Services Sectors: Total Enterprise Value / Revenue




Business Services Sectors: Total Enterprise Value / EBITDA





